**RESOLUTION NO. 26-5**

**A RESOLUTION OF THE BOARD OF DIRECTORS OF  
CALHAN FIRE PROTECTION DISTRICT  
ADOPTING A FEE SCHEDULE, 2026**

**WHEREAS**, the Calhan Fire Protection District ("District") is a political subdivision of the State of Colorado organized and operating pursuant to Title 32, Colorado Revised Statutes; and is authorized to adopt and enforce fire codes within its jurisdiction; and

**WHEREAS**, pursuant to C.R.S. § 32-1-1001(1)(j)(I), the Board of Directors of a special district has the authority to fix, and from time to time increase or decrease, fees, rates, tolls, penalties, or charges for services, programs, or facilities furnished by the District; and

**WHEREAS**, pursuant to C.R.S. § 32-1-1001(1)(k), the Board of Directors is authorized to adopt and amend policies necessary for the conduct of District business; and

**WHEREAS**, the District provides fire prevention, plan, review, inspection services, mitigation review, and other services necessary for the protection of life and property; and

**WHEREAS**, the Board of Directors finds that it is reasonable, necessary, and in public interest to adopt a Fee Schedule to ensure that the costs associated with providing certain District services are equitably recovered; and

**WHEREAS**, the proposed Fee Schedule has been presented to the Board for consideration at a duly noticed public meeting.

**NOW, THEREFORE, BE IT RESOVLED BY THE BOARD OF DIRECTORS OF  
CALHAN FIRE PROTECTION DISTRICT**

**Section 1. Adoption of Fee Schedule**

The Fee Schedule, as presented and attached hereto and incorporated herein by reference, is hereby approved and adopted as the official Fee Schedule of the Calhan Fire Protection District

**Section 2. Authority to Collect Fees**

The District is authorized to impose and collect fees in accordance with the adopted Fee Schedule pursuant to C.R.S. § 32-1-1001(1)(j)(I) and all other applicable laws.

**Section 3. Administration**

The Fire Chief, EMS Captain, Fire Marshal, and designated representatives are authorized to administer, interpret, and implement the adopted Fee Schedule.

#### **Section 4. Amendments**

The Board of Directors reserves the right to amend, modify, increase, or decrease the Fee Schedule from time to time by subsequent resolution.

#### **Section 5. Severability**

If any section, subsection, clause, or provision of the adopted Fee Schedule is held invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions.

#### **Section 6. Effective Date**

This Resolution shall take effect on February 12<sup>th</sup>, 2026, following its adoption by the Board of Directors.
